## Membership Agreement

Membership to Marigold Healing Society and its projects (Marigold Healing Center and others) entitles each member to enjoy the goods and services it provides to all members. Each person is required to be a member before purchasing goods or services. Marigold Healing Society has a large vision to heal the world by offering technology, healing modalities, workshops, products, etc. that enable healing in the body and production and/or education of holistic food sources to its community members that join. By joining Marigold Healing Society, a Private Membership Association and/or any associated website, social Media platform/group or other forum started by, created by, maintained, or organized by the Association. I agree to the terms and conditions of Marigold Healing Society, a Private Membership Association, Agreement as follows.

I waive all rights for liability to Marigold Healing Society or its projects. I willingly choose to partake in its services and without duress and can end my membership at any time by notifying the Manager of Marigold Healing Center to end my membership.
- The mission of this Association is to provide members with a forum to conduct business between members in the private domain with the protections guaranteed within the aforesaid Constitution and Charter remaining fully intact.
- The Association will recognize any person(s), natural or otherwise (irrespective of race, color, or religion) who have joined this Association or any social media group organized, created, or managed by this Association and is in agreement with these principles and policies as a member of this Association, providing said person has not been sanctioned, exercised, or otherwise banned by the association, and will provide a medium through which its individual members may associate for actuating and bringing to fruition the purposes heretofore declared.
